**4. First-aid Measures**

**FIRST AID - EYE CONTACT:** Immediately flush eyes with plenty of water for at least 15 minutes holding eyelids open. Get medical attention. Do NOT allow rubbing of eyes or keeping eyes closed.

**SPECIAL FIREFIGHTING PROCEDURES:** Containers can rupture and release highly toxic material if exposed to heat. Use water spray to keep fire-exposed containers cool. Containers may explode when heated.

### PERSONAL PROTECTION

## 10. Stability and Reactivity

**CONDITIONS TO AVOID:** Avoid contact with strong acid and strong bases.

**INCOMPATIBILITY:** Incompatible with strong oxidizing agents, strong acids and strong alkalis.

**HAZARDOUS DECOMPOSITION:** By open flame, carbon monoxide and carbon dioxide. When heated to decomposition, it emits acrid smoke and irritating fumes. Contains solvents which may form carbon monoxide, carbon dioxide, and formaldehyde.
