First Aid - Eye Contact: Immediately flush eyes with plenty of water for at least 15 minutes holding eyelids open. Get medical attention. Do NOT allow rubbing of eyes or keeping eyes closed. Remove contact lenses, if present and easy to do. Continue rinsing.

Unusual Fire and Explosion Hazards: Closed containers may explode when exposed to extreme heat due to buildup of steam. Vapors can travel to a source of ignition and flash back. 6. Accidental Release Measures

7. Handling and Storage

Follow all SDS and label precautions even after container is emptied because it may retain product residues. Ground and bond containers when transferring material from one vessel to another. Vapor can be ignited by static discharge. Avoid breathing fumes, vapors, or mist. Avoid prolonged or repeated contact with skin. Do not get in eyes, on skin or clothing. Rags, steel wool, or waste contaminated with this product may spontaneously catch fire if improperly discarded. Immediately after use, place contaminated materials in a sealed, water-filled metal container.

10. Stability and Reactivity

Conditions to Avoid: Avoid temperatures above 120°F (49°C). Avoid all possible sources of ignition. Avoid excess heat.
