Section 17 to 20, 64 and 135. Sale and Supply of Alcohol Act 2012

Pursuant to the Sale and Supply of Alcohol Act 2012 (the Act), **My Goodness Hampers Limited** (the licensee) is authorised to sell or deliver alcohol on or from the premises situated at **1/18-22 Constellation Drive Rosedale Auckland**, and known as **My Goodness Gift Baskets**, to any person for consumption off the premises and to supply alcohol free, as a sample, for consumption on the premises.

The authority conferred by this licence must be exercised through a manager or managers appointed by the licensee in accordance with Subpart 7 of Part 2 of the Act.

CONDITIONS

This licence is subject to the following conditions:

- (a) No alcohol sold is to be delivered on Good Friday, Easter Sunday, Christmas Day, or before 1pm on Anzac Day; or at any time after 11pm on any day and before 6am on the next day.
- (b) The remote sale of alcohol may be made at any time on any day, however the days and hours within which alcohol that has been sold may be delivered is restricted, as set out in condition (a) above.
- (c) Alcohol is not sold as a straight retail product.
- (d) Only alcohol as part of a gift basket or hamper may be sold under this licence.
- (e) Alcohol may be sold on the premises only during the following days and hours:

Monday to Sunday 8.00am to 10.00pm

- (f) Drinking water is to be freely available to customers immediately adjacent to any alcohol that is being supplied free as a sample on the premises.
- (g) The licensee must take reasonable steps to verify that the prospective buyer (and any prospective receiver) of any alcohol is not under the purchase age. For internet orders, the licensee takes such reasonable steps if the website has an age verification prompt:
 - (i) once when the prospective buyer first enters the internet site; and(ii) again, immediately before the sale of any alcohol is completed.
- (h) Every receipt or catalogue for the sale of alcohol sold remotely must display:
 - (i) The licensee's name.
 - (ii) The licence number.
 - (iii) The date on which the licence expires.
- (i) Any website that the licensee uses to sell alcohol remotely must prominently display the holder's name, licence number, the expiration date of the licence, as well as an image or a link to an image of the licence.
- (j) No intoxicated persons may be allowed to enter or to remain on the premises.
- (k) The licensee must ensure that A4 signs, stating 'Alcohol will not be sold to minors or intoxicated persons' are prominently displayed so as to be easily read from every point of sale.
- (I) The following conditions in relation to external signage apply:
 - (i) External or external-facing advertising of prices of alcohol products, or promotion of a special price / discount of an alcohol product must not be displayed on the façade of the building.
 - (ii) External advertising of alcohol products must not be displayed by way of flags, sandwich boards or bollard covers outside the premises.
 - (iii) Any alcohol-related lifestyle or branding images must not exceed 25 per cent of the façade of the premises.
- (m) The whole of the premises is undesignated.

DURATION

Subject to the requirements of the Act relating to the payment of fees, and to the provisions of the Act relating to the suspension and cancellation of licenses, this licence continues in force—

- (a) until the close of the period for which it was last renewed; or
- (b) if an application for the renewal of the licence is duly made before the licence would otherwise expire, until the close of the period of 3 years after the period for which it was last renewed.

This licence expires at the close of 26 October 2026 unless renewed.
