EMERGENCY AND FIRST AID PROCEDURES: **Eyes:** Flush with large amounts of cool running water for at least 15 minutes while holding upper and lower lids open. If irritation persists get medical attention immediately. **Skin:** Wash with soap and water. If irritation persists seek medical attention. **Inhalation:** Remove to fresh air. Seek medical attention immediately. If breathing stops give artificial respiration. Ingestion: Do not induce vomiting. Seek medical attention immediately.

STEPS TO BE TAKEN IN CASE MATERIAL IS RELEASED OR SPILLED: Allow propellant to evaporate. Maintain local exhaust and adequate ventilation. No smoking. Keep sparks, heat sources and open flame far away from spill or leak. Cover with absorbent material and sweep up. Wash area to prevent slipping. Dispose of soaked absorbent material in accordance with Federal, State and local laws.

WASTE DISPOSAL METHOD: Aerosol cans, when emptied and depressurized through normal use, pose no disposal hazard and should be recycled. Consult Federal, State and local authorities for approved procedures.
