## Description of necessary first aid measures

**Eye contact**

Small spill

#### **Precautions for safe handling**

# Section 8. Exposure controls/personal protection

### **Eye/face protection**

Safety eyewear complying with an approved standard should be used when a risk assessment indicates this is necessary to avoid exposure to liquid splashes, mists, gases or dusts. If contact is possible, the following protection should be worn, unless the assessment indicates a higher degree of protection: chemical splash goggles and/ or face shield. If inhalation hazards exist, a full-face respirator may be required instead.

#### **Skin protection**

**Hand protection**
