Section 4. First aid measures

Description of necessary first aid measures

: Immediately flush eyes with plenty of water, occasionally lifting the upper and lower Eye contact

Whether the chemicals are classified by NFPA or not, anyone using the 704 systems to classify chemicals does so at their own risk.
