IARC and NTP have determined that there is sufficient evidence for carcinogenicity of toluene diisocyanate to experimental animals and inadequate evidence in humans. IARC has designated carbon black as Group 2B - inadequate evidence for carcinogenicity in humans, but sufficient evidence in experimental animals. In 2006 IARC reaffirmed its 1995 finding that there is "inadequate evidence" from human health studies to assess whether carbon black causes cancer in humans. Further, epidemiological evidence from well-conducted investigations has shown no causative link between carbon black exposure and the risk of malignant or non-malignant respiratory disease in humans. Repeated exposure to n-butyl acetate caused fetotoxic and developmental effects in laboratory animals.
