# **SECTION 5: Fire-fighting measures**

## 5.1. Suitable extinguishing media

Closed containers exposed to heat from fire may build pressure and explode.

# **SECTION 6: Accidental release measures**

## 6.1. Personal precautions, protective equipment and emergency procedures

## **6.2.** Environmental precautions
