- Free-Air pump must be returned to Bullard with shipping charges prepaid.

- Free-Air pump must not have been misused, subjected to negligent use, or damaged in transport.
- The date of purchase is within one year warranty period. (A copy of the purchaser's original invoice showing the date of purchase is required to validate warranty coverage).

In no event shall Bullard be responsible for damages for loss of use or other indirect, incidental, consequential or special costs, expenses or damages incurred by the purchaser, notwithstanding that Bullard has been advised of the possibility of such damages.
