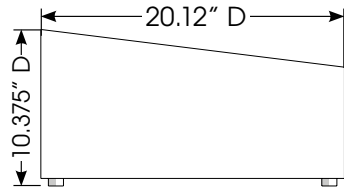

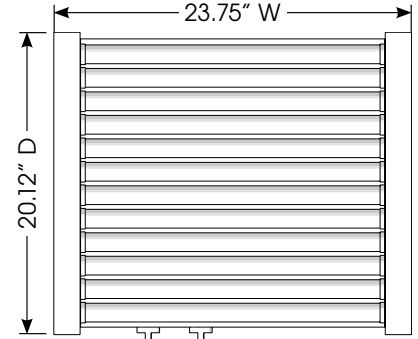

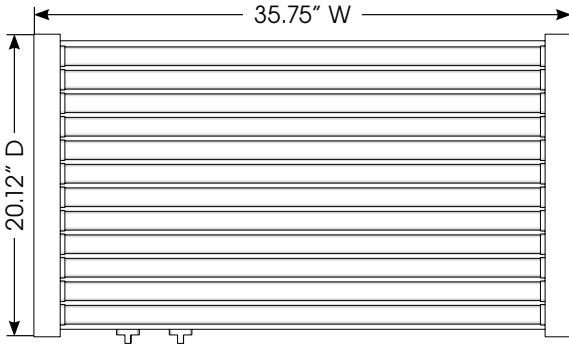
8033 - Front VIEW



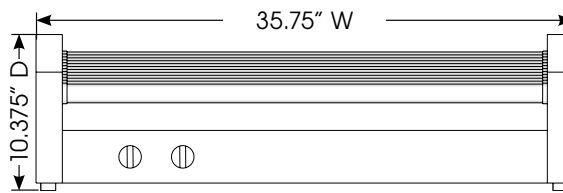
8033 - Side VIEW



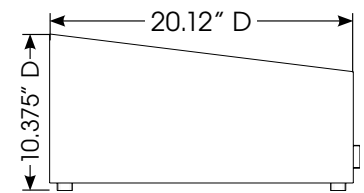
8033 - TOP VIEW
