### 4. First Aid Measures

**First Aid - Eye Contact:** Immediately flush eyes with plenty of water for at least 15 minutes holding eyelids open. Get medical attention. Do NOT allow rubbing of eyes or keeping eyes closed. Remove contact lenses, if present and easy to do. Continue rinsing.

**First Aid - Skin Contact:** Immediately flush skin with plenty of water for at least 15 minutes while removing clothing. Get medical attention immediately. Wash clothing separately before reuse. Wash contaminated clothing and decontaminate footwear before reuse.

**First Aid - Inhalation:** Remove to fresh air. If not breathing, give artificial respiration. If breathing is difficult, give oxygen. Get immediate medical attention. ### 6. Accidental Release Measures

**Steps to Be Taken If Material Is Released or Spilled:** Avoid runoff into sewers and waterways. ## 10. Stability and Reactivity

**Conditions to Avoid:** Avoid contact with strong acid and strong bases. Avoid contact with metals. Avoid excess heat.

**Incompatibility:** Incompatible with strong oxidizing agents, strong acids and strong alkalies. Avoid contact with water. Product slowly corrodes copper, aluminum, zinc, and galvanized surfaces.

## 11. Toxicological Information

**Effects of Overexposure - Eye Contact:** Causes eye burns. Irritating, and may injure eye tissue if not removed promptly. High vapor concentrations can irritate eyes, nose and respiratory passages. May cause eye irritation.

**Effects of Overexposure - Skin Contact:** Prolonged or repeated skin contact may cause irritation. Substance is corrosive. Causes severe skin burns. Causes skin irritation. Allergic reactions are possible. May cause skin sensitization, an allergic reaction, which becomes evident upon re-exposure to this material.
