- Owners must ensure that signs are posted which prohibit parking in a manner that obstructs access by fire department vehicles to the building or to streets, yards and roadways provided for fire department access.



Signs

- Indicate the identity and telephone number of the person/firm in charge or control of the private property who can be contacted
- Use text:
 - "NO PARKING"
 - "UNAUTHORIZED PARKING PROHIBITED" during specified time periods
 - "UNAUTHORIZED PARKING PROHIBITED"
- Black letters and border on a white background
- Size is 750mm W x 600mm H

Signs required for direction and convenience of the public, including signs identifying restrooms or parking entrances

- May not exceed 0.5m^2 in sign surface area

Residential on-site identification signs or warning signs (ex. "Private Property" sign and similar)

May not exceed 3 square feet each in surface area

Parking Instructions Type (Multiple Use Sector)

- Sign can be attached or free-standing
- Maximum size of 24 square feet per sign
- Height maximum of 10 feet
- Attached location below 25 feet in height
- Free standing location set back from the public road right-of-way by a minimum distance equal to one half of the height of the sign

Accessory off street parking and loading areas

- Illuminated or non-illuminated directional signs for control of traffic movement
 - Limited to a maximum of 6 square feet in sign surface area per sign, maximum height of 6 1/2 feet above curb or grade

Illuminated or non-illuminated parking area sign, or signs identifying the parking area and setting forth the rules governing the use of a parking area

- Ex. "No Parking" "Public Parking" "private Parking" etc.
- Maximum of 6 square feet in sign surface
- Maximum height of 6 1/2 feet above curb or grade
- Warning signs surface must not exceed 6 square feet

Sign Requirements

- Carry the text "No Smoking" in capital or lowercase letters (or)
 - Consist of at least two contrasting colours
 - Text shall not be less than 28mm in height



- Consist of the following graphic symbol, on a white background with the circle and interdictory stroke in red
- Diameter of the circle is not less than 100mm in size

Residential on-site identification signs or warning signs (ex. "Private Property" sign and similar)

- May not exceed 3 square feet each in surface area

- No specific requirements

Underground Parking

204-986-5140, Building and Permits Office

 No specific requirements that they know of, would be under the zoning bylaw with other Parking provisions



Zoning Bylaw

- All relevant information is found under No Parking

Fire Safety Plan Box

- The City of Winnipeg does not have any specific guidelines for a fire safety plan box
- Recommend that it be properly identified and big enough to hold the plan

- Must be a Medeco Keyed Lock Box
 - Must fill out a "REQUEST FOR KEYED LOCK BOX INSTALLATION OR CHANGE OF KEYS" form

General

- Signs that designate permanent rooms or spaces should include, where possible, tactile characters, Grade 1 Braille and numbers
- Minimum illumination level of 200 lux

Letters and Numbers

- Not be stylized or italicized
- Be sans serif fonts
- Have Arabic numbers
- Width-to-height ratio between 3:5 and 1:1
- Stroke width to height ratio between 1:5 and 1:1-
- Eggshell, matte or other glare free finish (includes backgrounds)
- Colour contrast of a minimum 70% with background
 - Contrast = ((B1 B2)/B2) * 100



Minimum character height, mm	Maximum viewing distance, mm
25 mm (1 in.)	750 mm (29 1/2 in.)
50 mm (2 in.)	1.5 m (5 ft.)
75 mm (3 in.)	2.3 m (8 ft.)
100 mm (4 in.)	2.5 m (8 ft. 2 in.)
150 mm (6 in.)	4.6 m (15 ft.)
200 mm (8 in.)	6.0 m (19 ft. 8 in.)



Tactile

- Raised at least 0.8mm, not sharply edged
- Be between 16mm and 50mm
- Sans serif font, accompanied by Grade 1 uncontracted Braille

Pictograms

- Border dimension shall be 150mm minimum in height
- Raised 0,8mm 1.5mm from the background surface






Parking

- Be at least 300mm x 450mm
- Displays a designated disabled parking space sign as specified in the Manual of Uniform Traffic control Devices for Canada

Single Stage Fire Alarm System and No Elevators

IN CASE OF FIRE

UPON DISCOVERY OF FIRE

- ▶ Leave the Fire area immediately
- Close and latch all doors behind you
- > Activate the fire alarm pull station to notify building occupants
- > Leave the building immediately via the nearest exit
- > Telephone the Winnipeg Fire Paramedic Service DIAL 9-1-1

UPON HEARING FIRE ALARM

- LEAVE the <u>BUILDING</u> immediately via nearest exit
- Take your keys
- <u>CLOSE</u> and latch <u>DOORS</u> behind you do not lock

IF YOU ENCOUNTER HEAVY SMOKE

- STAY in your suite IF you are UNABLE TO EXIT
- ▶ DIAL 9-1-1 and await further instructions

REMAIN CALM

Two-Stage Fire Alarm System

IN CASE OF FIRE

UPON DISCOVERY OF FIRE

- ➢ Leave the Fire area immediately
- Close and latch all doors behind you
- > Activate the fire alarm pull station to notify building occupants
- > Leave the building immediately via the nearest exit or stairwell exit
- > Telephone the Winnipeg Fire Paramedic Service DIAL 9-1-1

DO NOT USE ELEVATORS

UPON HEARING FIRE ALARM

INTERMITTENT SIGNAL-

> Stand by and prepare to leave the building

IF CONTINUOUS SIGNAL-

- LEAVE the BUILDING immediately via nearest exit or stairwell exit
- Take your keys
- <u>CLOSE</u> and latch <u>DOORS</u> behind you do not lock

IF YOU ENCOUNTER HEAVY SMOKE

- Return to or stay in your suite or office if you are unable to leave by an alternate exit.
- DIAL 9-1-1 and await further instructions REMAIN CALM

Single Stage Fire Alarm System with Elevators

IN CASE OF FIRE

UPON DISCOVERY OF FIRE

- Leave the Fire area immediately
- Close and latch all doors behind you
- > Activate the fire alarm pull station to notify building occupants
- \blacktriangleright Leave the building immediately via the nearest exit or stairwell exit
- Telephone the Winnipeg Fire Paramedic Service DIAL 9-1-1

DO NOT USE ELEVATORS

UPON HEARING FIRE ALARM

- LEAVE the <u>BUILDING</u> immediately via nearest exit or stairwell exit
- Take your keys
- <u>CLOSE</u> and latch <u>DOORS</u> behind you do not lock

IF YOU ENCOUNTER HEAVY SMOKE

- Return to or stay in your suite or office if you are unable to leave by an alternate exit.
- DIAL 9-1-1 and await further instructions REMAIN CALM
